EXPLANATION:

This emergency order prohibits the retention of naturally-produced king salmon and the use of multiple hooks while sport fishing in the Kasilof River from Wednesday, May 1 through Sunday, June 30. Naturally-produced king salmon have an adipose fin and may not be removed from the water and must be released immediately.

REGULATION:

The provisions of 5 AAC 56.122. (a)(8)(A)(i), (ii), and (B)(ii) are superseded by this emergency order. Under this emergency order, the following provisions are effective 12:01 a.m. Wednesday, May 1 through 11:59 p.m. Sunday, June 30, 2024.

5 AAC 56.122. Special provisions for the seasons, bag, possession, annual, and size limits, and methods and means for the Kenai Peninsula Area.

(a)(8) Kasilof River drainage, excluding Crooked Creek and Tustumena Lake and its tributaries:

(A) king salmon may be taken from January 1 – June 30, upstream of the Sterling Highway Bridge, and from January 1 – July 31, downstream of the Sterling Highway Bridge; bag and possession limit for king salmon 20 inches or greater in length is one fish; annual limit of five king salmon 20 inches or greater in length; a harvest record is required as specified in 5 AAC 75.006; from May 1 – June 30,

(i) the bag and possession limit for king salmon 20 inches or greater in length is two hatchery fish; a king salmon 20 inches or greater in length that is removed from the water must be retained and become part of the bag limit of the person originally hooking it; a person may not remove a king salmon from the water before releasing the fish;

(ii) naturally-produced king salmon of any size may not be retained; a person may not remove a naturally-produced king salmon from the water before releasing the fish;

(B) the following special provisions apply in that portion downstream of the Sterling Highway Bridge:

(ii) in flowing waters, from May 1 – June 30, only one single hook or single-hook, artificial lure, with bait may be used;

JUSTIFICATION:

As provided by 5 AAC 57.160. *Kenai River and Kasilof River Early-Run King Salmon Management Plan*, ADF&G shall manage the Kasilof River early-run king salmon sport and guided sport fisheries to achieve the sustainable escapement goal (SEG), to provide reasonable harvest opportunities over the entire run while ensuring adequate escapement of naturally-produced king salmon, and to minimize the effects of conservation actions for the Kenai River on the Kasilof River.

ADF&G has issued an emergency order (EO 2-KS-1-08-24) to close the Kenai River early-run king salmon sport fishery. This will likely result in an increase in the sport fishing effort and catch of king salmon in the Kasilof River. ADF&G manages the Kasilof River king salmon sport fishery to achieve a sustainable escapement goal of 700–1,400 naturally-produced king salmon as monitored through a weir at an ADF&G facility located on Crooked Creek. From 2018–2023, restrictions were implemented to increase king salmon numbers to try to achieve the SEG for naturally-produced king salmon and the broodstock goal for increased hatchery king salmon stocking was achieved. The Crooked Creek SEG was met in only one out of the last three years. Broodstock goals for naturally-produced king salmon have also not been fully achieved the last couple of years.

This emergency order to restrict the early-run king salmon sport fishery in the Kasilof River during 2024 is a continuation of an incremental approach to maintain harvest opportunity while assuring the SEG of naturally-produced king salmon and stocking goals can be achieved as king salmon production throughout Cook Inlet has been low. This action will sustain natural production at Crooked Creek and maintain harvest opportunity for hatchery king salmon in the Kasilof River early-run king salmon sport fishery, as well as other Southcentral Alaska king salmon sport fisheries supplemented by Crooked Creek king salmon stock.
