Effective Date: 12:01 a.m. Tuesday, April 1, 2025

Expiration Date: 11:59 p.m. Monday, September 15, 2025, unless superseded by subsequent emergency order.

EXPLANATION:

This emergency order reduces the king salmon bag and possession limit in the salt waters of the Alaska Peninsula and Aleutian Islands Area to one fish from April 1 through September 15.

REGULATION:

The provisions of 5 AAC 64.020(1)(B) are modified by this emergency order. Under this emergency order, the following provisions are effective from 12:01 a.m. Tuesday, April 1 through 11:59 p.m. Monday, September 15, 2025:


5 AAC 65.020. General provisions for seasons and bag, possession, annual, and size limits for the Alaska Peninsula and Aleutian Islands Area.

(1) king salmon:

(B) in salt waters: may be taken from January 1 through December 31; bag and possession limit of two fish; no size limit; no annual limit; except from April 1 through September 15; bag and possession of one fish; no size limit;

JUSTIFICATION:

The Gulf of Alaska fresh waters saw record low king salmon runs in many drainages in 2024 and additional restrictions are needed for conservation of the king salmon runs in the 2025 season. King salmon stocks throughout Cook Inlet and Gulf of Alaska have returned at levels that have failed to provide yield, triggering stock of concern designation for many of them. King salmon stocks are experiencing a period of low productivity and a more comprehensive and precautionary management approach to king salmon sport fisheries in the northern Gulf of Alaska is necessary. Additionally, the 2025 forecasts of king salmon stocks in Gulf of Alaska and Cook Inlet are below the lower end of established escapement goals warranting restrictions to king

salmon sport fisheries throughout the region. These restrictions to Gulf of Alaska king salmon limits, in some cases in addition to management plans and actions taken by the Alaska Board of Fisheries, are warranted to reduce harvest of king salmon in these mixed stock fisheries.
