SPORT FISHING Emergency Order

EXPLANATION:

This emergency order closes sport fishing for king salmon in all flowing waters of the Tanana River drainage. King salmon may not be targeted and those caught incidentally while fishing for other species may not be removed from the water and must be released immediately.

In addition, the use of bait is prohibited in all Tanana River tributaries.

REGULATION:

The provisions of 5 AAC 74.010(b)(1), (c)(12), (d)(2), (5)(B), (15), (16)(B), and (18) are superseded and (d)(23) is added by this emergency order. Under this emergency order, the following provisions are effective 12:01 a.m. Monday, March 31 through 11:59 p.m. Tuesday, September 30, 2025:

5 AAC 74.010. Seasons, bag, possession, and size limits, and methods and means for the Tanana River Area.

- (b)(1) sport fishing for king salmon is closed; king salmon may not be retained or possessed; king salmon caught must be released immediately; a person may not remove a king salmon from the water before releasing the fish;
- (c)(12) in the Goodpaster River drainage sport fishing for salmon is closed;
- (d) In the Tanana River Management Area, the following special provisions to methods and means apply:
 - (2) in the Chatanika River and its tributaries, only unbaited, artificial lures may be used;
 - (5) in the Chena River and its tributaries, including Chena Slough (Badger Slough), (B) the use of bait is prohibited;
 - (15) in the Salcha River and its tributaries, only unbaited, artificial lures may be used;
 - (16) in Shaw Creek,
 - (B) downstream from the Richardson Highway Bridge, only unbaited, artificial lures may
 - (18) in the Tanana River within a two-mile radius of Shaw Creek, only unbaited, artificial lures may be used;
 - (23) in all Tanana River tributaries, only unbaited, artificial lures may be used.

JUSTIFICATION:

King salmon stocks in the Yukon River drainage, including the Tanana River drainage, continue to experience historically low productivity for both Canadian and Alaskan stocks. The 2025 king salmon run is not expected to meet escapement goals in the Tanana River drainage, nor provide for subsistence opportunity. The 2025 Yukon River drainage king salmon run is expected to be similar to the previous four years (2021-2024) when each run (51,000-129,180 fish) was not sufficient to meet spawning goals. In the Tanana River drainage, the Chena and Salcha Rivers are the two largest producers of king salmon in Alaskan waters. The spawning escapement goal for the Salcha River is 3,300 – 6,500 king salmon and for the Chena River it is 3,300 – 5,700 king salmon. In 2024, the Salcha River and Chena Rivers each had an estimated return of less than 1,000 king salmon and neither river has achieved their king salmon escapement goal in the past four years. Therefore, a preseason closure of sport fishing for king salmon in the Tanana River drainage is warranted.
