To the Alaska Joint Board of Fisheries (BOF) and Board of Game (BOG) Committee:

Ahtna Intertribal Resource Commission (AITRC) requests that the BOF delay its meetings for Prince William Sound/Upper Copper Prince William Sound/Upper Susitna Finfish and Shellfish so that it could be safely held in person. We similarly request that the BOG delay its meeting for the Southcentral region. Currently, the BOF meeting is scheduled to be held telephonically, at the end of March, while the BOG meeting has been postponed and has yet to be rescheduled.

AITRC was formed in 2011 to represent and support the eight Ahtna tribes on fisheries and wildlife management issues, working to build resource stewardship programs throughout the Ahtna traditional-use area. This area include GMUs 11 and 13, as well as the upper Copper and upper Susitna River basins. The current BOF cycle includes numerous proposals that would affect state subsistence, personal-use and sport fisheries on the Copper River. Holding BOF and BOG meetings remotely would make it harder for Ahtna tribal members to effectively participate in the state regulatory process. Some tribal members, especially elders, have limited access to technology, and find it more difficult to communicate by phone or internet, where connections can be spotty and nonverbal communication is diminished.

One of the benefits of in-person meetings is that they facilitate relationship-building between tribal members, fisheries managers, members of regulatory bodies, and other stakeholders. Through in-person interaction, members of different user-groups have the opportunity to work toward common understanding on the issues. Much of this comes from conversations that occur in the hallways, at lunch hour, and otherwise outside of the formal meeting program. Such relationship-building facilitates greater communication and mutual understanding between stakeholder groups, an important component of more effective fisheries

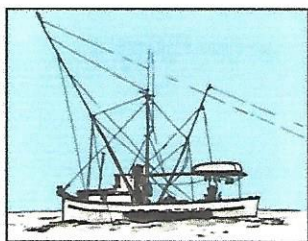

The Alaska Outdoor Council is a statewide conservation organization of hunters, trappers, fish gathers, and outdoor enthusiast. The Outdoor Council has had representatives participate in the Boards of Fisheries and Game process since they were created by the Alaska Legislature. Due to the 2020 outbreak of COVID-19 in Alaska and the state's implementation of safety precautions it's reasonable for the Boards to consider delaying scheduled Spring 2021 meetings to a later date in 2021.

Scheduling a web conference to allow Boards to act on proposals needing annual reauthorization under the Alaska Administrative Code makes sense. Proposals that may change the allocation of fish or game resources should not be conducted via a web conference. The boards allocation process works because users come face-to-face to hash out differences and compromise on regulatory changes. The public's opportunity to comment on the Departments position on their proposals is provided through oral comments before the boards and/or Recorded Copies (RC) during the meeting. These necessary opportunities would be complicated if participating in a Web conference. Worse yet the process could be overrun with; anti-hunting, trapping, game management, hatchery, or commercial fishing advocates who wouldn't otherwise be available to participate in the Boards process, thus extending the amount of time necessary for the boards to conduct oral testimony.

The Alaska Outdoor Council would be supportive of the boards meeting in a web conference to deliberate on statewide proposals only. An analysis of how that process worked may be beneficial in the future when funding costs prohibit the boards from traveling to statewide locations.

RE: SE Meeting postponement

Dear Mr. Haight and members of the Alaska Board of Fisheries,

Alaska Trollers Association (ATA) represents nearly 2,000 permit holders. Power and Hand Troll permits are 85% Alaska resident owned, which is one of the very highest proportion of resident-permit-ownership in our state. Our fishermen reside largely throughout the SE Island communities where there is little else going on economically so trolling is a significant part of the SE AK economy. Salmon trolling is over a century old and due to ever decreasing harvests, many trollers are diversified into other fisheries, such as shrimping or longline, to survive.

We are commenting again on the scheduling of the Board's upcoming Southeast meeting in light of the Covid pandemic. As April quickly approaches, we see increasing indicators that the virus is not abating. While some may be willing to risk illness, many will not and we see this as serious impediment to participation in a highly participatory process. We do not believe virtual meetings allow for the full spectrum of information sharing and public engagement in your regulatory process.

We urge the Board to postpone our meeting until January 2022 as there is really no imminent danger to the resource in further postponing any potential regulatory modifications in the eight months prior to January 2022 since the department (ADFG) has the ability to manage by Emergency Order (EO) if necessary. Also, any unused FY 2021 (July 2020 through June 2021) budget remaining can be re-appropriated through the legislative budget process for the FY 2022 budget.

We request your consideration of this postponement in order to maintain the integrity of the well-regarded and highly interactive Board of Fisheries process.

Hello members of the Board of Fisheries,

I am writing to urge you to take into account the worsening nature of the COVID-19 pandemic and postpone the Board of Fisheries meeting in Ketchikan this April. At the current rate of vaccination, there will likely still be hundreds of elders and vulnerable individuals who will be unprotected in April. Hosting a large gathering would irresponsibly put many community members at risk.

Postponing the meeting would provide time to make alternative arrangements, like transitioning the meeting to a virtual setting. Providing a platform that gives meaningful opportunities for remote participation, that gives careful thought to accessibility for all community members, would be the best option considering the enduring pandemic. Also, given the difficulty of travel in Southeast Alaska, a well-designed virtual meeting could greatly improve access and participation at BOF meetings and should be considered as a permanent solution.

Hello,

I am writing to urge the Board of Fish to postpone the 2021 Southeast and Yakutat Finfish and Shellfish meeting until it is safe to travel and gather in-person.

By April, we are still likely to be in the midst of the COVID-19 pandemic and the Alaska vaccination campaign. Meaning that an in-person gathering would likely be skewed to folks unconcerned about travel, thereby leaving out folks at higher risk of infection, including elders, those with pre-existing conditions, or those in communities with less access to medical intervention.

In general, I am supportive of incorporating virtual options into future BOF meetings, but as a supplement, not a replacement, for in-person participation. A dual model would help avoid barriers both from travel (cost, time, family/work obligations) and from lack of access to technology.

Please take all actions possible to insure that the BOF process is safe, accessible and equitable for all participants.

Dear Members of the Boards of Fish and Game:

Concerned Area M Fishermen (CAMF) is writing to ask that the Boards strongly consider postponing the current meeting cycle until the public can safely meet for in person meetings after the health risk from Covid-19 has passed. This would likely mean pushing the meeting cycle back by one year.

Although our regulatory area is not on the cycle this winter, we can speak, from long experience at Board of Fisheries meetings, that in person participation is vital to stakeholders and also to a healthy Board process. We feel that such participation would be significantly lacking with regulatory meetings held online, and the public would be deprived of the opportunity to interact with Board members outside of the limits of a 3 minute testimony. Everybody, public and the Boards, would be the poorer under such a scenario.

Quite frankly, most of the issues the Board may consider (at least in Fisheries) are allocative in nature, and are revisits of similar proposals considered under many preceding Boards. Unfortunately, these are the proposals that are often the most contentious, and are therefore the most beneficial for the public to be directly involved in--and also equally beneficial for the Board-- when it comes to weighing the merits of these proposals. For these reasons, CAMF feels the public is far better served by in person meetings, and we ask the Boards to schedule when full public participation is warranted.

Members of the Alaska Joint Board of Fisheries and Game,

Cordova District Fishermen United is a 501(c)5 non-profit organization that advocates on behalf of the commercial fishing fleet of the Copper River, Prince William Sound. CDFU is a regular presence at Board of Fisheries meetings and we value the established relationships we have built with members of the Board, members of various user groups around the state, and state employees during these meetings. We value and appreciate the open public process that exists with the current Board of Fisheries structure, and continue to have concerns as expressed previously in our letter to the Board of Fisheries in September.

Many organizations and state agencies have been stretched to the brink over the last 10 months, involved in critical planning processes and logistical challenges to ensure safe, continuous operations throughout the pandemic. Leaders from stakeholder groups continue to navigate the ongoing challenges presented, yet many remain in crisis mode as we move closer to the active fishing seasons with a pandemic still roaring full force. Postponing the meetings from spring to this coming winter, means that both individuals involved in spring fisheries and the organizations that represent them, can fully prepare and participate in the process as usual, without the distractions of juggling fishing, pandemic, and regulatory cycles concurrently.

Unfortunately, as the pandemic has progressed, the likelihood of a safe in-person meeting in March continues to decrease. Cases continue to rise, and at the time of this writing, Cordova has one of the highest current case counts to date. With vaccines on the horizon, but slow to roll out, there is hope for a regular, full Prince William Sound cycle meeting during the typical timeframe this coming December without the worry of putting participants and state employees at risk, and without the concerns that come with attempting to conduct these important regulatory meetings remotely.

Regarding virtual meetings for the Board of Fisheries, most regular attendees know that the



very open public process cannot happen without an in-person meeting. A virtual meeting to discuss regulatory language would degrade the quality of the meetings that the public has come to know and trust, and potentially exclude valuable perspectives due to a lack of technological access. Further, much of the cooperation between user groups happens during the breaks, at lunch, and after each meeting day, and the in person access to speak directly with Board members would be lost with a virtual meeting. It is simply not the same, and meetings may have very different outcomes without these important qualities.

Virtual meetings would be a complete shift from the openness of previous Board of Fisheries meetings, and has the potential to change the entire social fabric of the State of Alaska, particularly in coastal communities where regulatory changes in all fisheries have profound impacts on the people, the resource, and the economy.

With this in mind, we urge the Board to consider postponing the March meeting until December 2021. This inevitably and unfortunately means that regulatory changes will be delayed longer than is ideal, however, it also means that regulatory impacts to our fisheries will not occur without adequate, comprehensive, and valid public process and access to the Board of Fisheries meetings. Ultimately, the potential for better and greater public involvement and more fair regulatory outcomes will occur if the current meeting cycle is postponed.

I disagree with moving any meeting to web based or "zoom" based. Stakeholder involvement is needed to the Board of Fisheries process. Remote meetings limit Stakeholder involvement and participation. The remote meeting format changes the format of the Board of Fisheries meeting and will discourage or possibly eliminate some stakeholders from participating in the process. The Board of fisheries meeting normally brings together interested parties from multiple communities and viewpoints to discuss and hopefully resolve differences. I realize that there is higher risk for in person meetings due to the current pandemic, however with the vaccine roll out gaining momentum, the Vaccine should be available to most of the general public through out the 2021 year. This would mean with some safe guards in place postponing the meeting to normal format would be the best solution in these times.

Time of year that meeting are held are important for participation. I am a commercial fisherman in the Prince William Sound Area. The normal time for the Board of Fisheries meeting is December or January. If this meeting were to be scheduled for spring it would limit participation as our fishing season or preparation for the upcoming season could be underway and limit the ability for participation. The reasoning of this comment is that once on the grounds or in preparation for the season many of the participants would not have the venue or equipment available to participate as they would be away from their respected home or office. There is also the likely lack of connectivity depending upon where their fishery is located.

All participants, stakeholders, businesses, State agencies, and representative organizations have been faced with many challenges with the current pandemic and the continually changing regulations, mandates, and also fears which have taken their focus away from or discouraged participation in the proposal process. It seems that there is a light at the end of the tunnel with the vaccine and postponement of meeting until they can be held in a normal manner is the best for all involved in the process.

I appreciate the opportunity comment on this very important issue in order to keep the Board of Fisheries process open and fair to all interested parties.

Dear Joint Boards members, staff, and participating public.

My name is Eric Jordan, a lifelong Alaska resident, fisherman, hunter, and harvester. I have been involved in fisheries politics since I listened to my dad practice his speeches on the importance of voting for statehood and gaining control of our fisheries management in the mid 50's. I became involved in the BOF and BOG processes shortly after moving to Juneau in 1972. I have helped found numerous fisheries and conservation groups such as the Southeast Alaska Trout Fishing Association in the early 70's, the South East Alaska Conservation Council in the mid 70's, the Northern Southeast Regional Aquaculture Association in 1977, and the Chum Trollers Association most recently. I have served 8 years on the AP to the NPFMC, the BOF, over 40 years on the Sitka Fish & Game Advisory Committee, and numerous fisheries and conservation Boards. I have held elected office to one or another fisheries or conservation group board or council continuously since the early 70's. So, I understand how important the Board processes are for conservation, management, and sharing of our fish and wildlife resources.

I applaud the decision by the joint boards to consider rescheduling the spring meetings during the time of Covid for multiple reasons but I will focus on the questions asked about in the announcement.

1. Conduct some or all of the meetings through web conferencing. I am familiar with zoom, google conferencing, and other web meeting teleconference tools through my involvement with many groups. Based on my experience and abilities with these technologies I believe they give great advantage to those of us more adept than many stakeholders I see struggling with the systems. Thus, in effect disenfranchising equal participation and voice in the processes. Plus, as effective as I am in communicating and using these technologies, I find them as a very poor and ineffective substitute for in person meetings which I know, as a former board member, and public participant, are essential for the best decisions. So, I strongly recommend no web conferencing except for emergency decisions that will do irreparable harm if postponed.

2. Should meetings be postponed until the 2021/2022 meeting cycle? I was involved when the BOF went from annual meetings for every area to staggering the meetings to every three years. I think it has mostly worked with the addition of the ability for ACR's. In SE fisheries proposals and processes where I am most involved, I dont see any conservation or management proposals that cant afford to be postponed till January or February. So, I strongly recommend postponing SE fisheries proposals until at least January or February of 2022. While I have already recieved my first shot of vaccine, many others will not likely be vaccinated by spring. Plus, many of us in SE Alaska are fishing in the spring. A spring meeting either in person or by web conferencing will disenfranchise me and many other stakeholders.

3. impacts on public by postponement. While there undoubtedly will be impacts by postponement my opinion is they are much less onerous than either in person or web conference meetings this spring.

Finally, those of us who harvest fisheries and wildlife resources in Alaska adapt to changes in weather, abundance, regulations, etc all the time. I think that the Board of Fish and Board of Game meetings work best when the public and the Advisory Committees can provide input and feedback freely and in person. We think it will be extremely difficult to have meaningful meetings and discussions with the current format that is allowed. Zoom will not work when there are multiple groups and hundreds of individuals that want to participate. The impact of public testimony will be minimized when done with video.

The COVID 19 virus is still highly contagious and state medical experts still do not have it under control. The entire state of Alaska has been adversely impacted and it will be months/years maybe, before we return to anything resembling normal if ever. 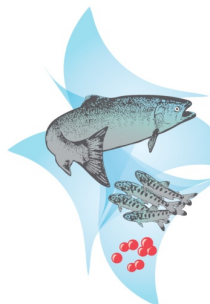

The unique system the State of Alaska uses to create regulatory change requires public participation at the highest level. The Prince William Sound Aquaculture Corporation (PWSAC) would like to formally declare its support for postponement of Board of Fisheries (BOF) meetings until the COVID-19 pandemic has subsided allowing for full and open participation by all stakeholders. Specifically, PWSAC supports rescheduling the March 4th, 2021 Hatchery Committee and the March 20th thru April 5th, 2021 Prince William Sound/Upper Copper River and Upper Susitna Rivers Finfish and Shellfish meetings.

Currently, the COVID-19 pandemic makes full public participation from stakeholders difficult and a risk to human health. None of the proposals for the upcoming meetings are emergency in nature and can appropriately be addressed later when the stakeholder participation can be safely resumed.

During the current pandemic PWSAC has instituted stringent policies and procedures to minimize risk to human health. Lastly, PWSAC believes the use of video conferencing limits participation and does not allow for open and direct dialogue between user groups that is a critical and normal part of the in-person meeting format.

Please consider our comments as you discuss the 2021 meeting cycle. We look forward to working with the Board of Fisheries and are happy to address any questions or concerns members may have in the coming months. We look forward to returning to a more normal meeting process soon.

Dear Board of Fisheries and Board of Game members,

The comments below were sent to the Board of Game for the upcoming work session on January 21st, and we copy them to you now as we believe they are also relevant to Board of Fisheries as both boards consider the same scenarios.

Postponement of 2021 Meetings

Due to the ongoing pandemic and valid concerns of holding the Region IV and Statewide meetings in person this spring, RHAK supports postponing the meetings until 2022, and moving the entire cycle ahead a year. We believe the public will be unfairly disenfranchised if the board holds these meetings over web-conference.

If the board postpones the 2021 Region IV and Statewide meetings until 2022, we respectfully request that new proposals be allowed to come in for those meetings, along with new comments on those proposals. Essentially, an entirely new call for Region IV and Statewide proposals and subsequent comments, in addition to the existing proposals and comments.

Rationale: population and harvest data and individual hunting experiences change from year to year, and it is that data and experiences the public and the Department utilize when considering drafting a proposal. The board also considers this same information for board-generated proposals. It has already been nearly a year since the proposals for the 2021 meetings were sent in, and we already have new Department harvest and population data that the public and the Department should be allowed to review and then comment on with a proposal.

We are in unprecedented times and the board has already had to make some tough decisions due to the pandemic. And we believe those were the right call.

Any new proposals should not duplicate or serve the same intent as proposals already submitted, though updated data should be allowed to be added to an existing proposal.



We do indeed have the best public system of wildlife management in the country and we want to keep it that way. Please allow the public and the Department to send in new proposals for the Region IV and Statewide meetings by the May 1, 2021 deadline if the 2021 Region IV and Statewide meetings are postponed until 2022.

My name is Tad Fujioka. I have served on the Sitka Fish & Game Advisory Committee as the Trapping representative since 2005, including two terms as Chair. I have personally attended and testified at multiple BoF/BoG meetings. Direct face-to-face communication, both on-record and off, is intrinsic to this uniquely-Alaskan means of establishing hunting and fishing regulations. It is conceivable that virtual communication could be utilized for a bare-bones process if necessary in emergency situations, or when the subject matter is very straightforward without need for subjective interpretation or judgment.

However, Zoom or other contemporary on-line meeting apps will in no way replicate the traditional process of physically getting representatives of all user groups together. Without a great deal of training of all parties involved, and not-yet-widely-available technology, the complexities of topics that are biologically, statistically or politically complicated will not be able to be communicated efficiently to board-members without direct back-and-forth in-person dialog. There will be minimal ability for groups to be able to directly negotiate with one another in a virtual setting. These factors will mean that board members will be repeatedly forced to chose between extreme initial positions while lacking critical first-hand or even second-hand information on the topic.

Alaska may someday get to the point of being able to have heavily-attended virtual public meetings where the all members of the public are fairly and efficiently heard, but to jump directly from our current system of traditional meetings to a fully (or even largely) virtual format in 2021 would risk board members making woefully uninformed decisions that would harm Alaskan fish and game management through at least the next board cycle, and potentially harm the resources much longer. Hence I respectfully request that that consideration of the great majority of Fish and Game proposals (including the three fisheries proposals that I have submitted this cycle) be postponed until large in-person meetings are safe for all Alaskan who wish to fully participate in this special process that you board members have volunteered to lead.

The Juneau-based Territorial Sportsmen, Inc. (TSI) respectfully requests that the Southeast Alaska/Yakutat Board of Fisheries meeting originally scheduled for January, 2021 be postponed until effective safeguards can be developed and implemented to deal with the ongoing COVID-19 pandemic. We believe virtual meetings do not allow for the full spectrum of information sharing and public engagement in the regulatory process, and we further believe it to be highly unlikely that meeting participants will be vaccinated by April 2021 (even if they choose to be), thereby creating a health risk to participants.

While virtual meetings have become used for bringing organizations and the public together in the face of the pandemic, we oppose virtual meetings as a venue for the Board of Fisheries process for the following reasons:

1. Southeast Alaska fisheries issues are diverse, complicated, and challenging for board members as well as for members of the participating public. Added to this is the fact that several new board members have come onboard since the last Southeast meeting three years ago. From our experience, personal interactions with board members at scheduled meetings is critically important for members of the public who have interests and insights on issues that they wish to share and have considered in the decision-making process.
2. Board proposals are often amended, sometimes multiple times, before their final adoption. Through Alaska's open board process, the public often helps to formulate and



guide final amended regulatory products through interactions with board members at breaks, by submitting timely Record Copies (RCs), and by participating in impromptu gatherings to develop acceptable and suitable regulatory language. This would all be lost if the upcoming SE Alaska meeting were to be held online, with the risk of promulgating regulations that lack the benefit of broad, critical, and useful input from various and diverse interests.

TSI believes the current fisheries regulations can withstand another season without the need for a board meeting. This belief is based on our knowledge that department staff has Emergency Order (EO) authority to address fisheries conservation issues in a timely manner, and with the knowledge that the Commissioner and Board both have Emergency Regulation (ER) authority to handle conservation, allocation, or other emergencies, including stocks of concern, without general board meetings.

As far as other areas of the state are concerned, the fairest way to deal with postponement of the meetings for this cycle is to postpone all areas by one year, effectively creating a one-time 4-year cycle for regulatory board meetings.

When the board takes up Southeast fisheries issues in January 2022, it can do so with direct and meaningful in-person input that is critical to sound decision making and the public process.

Members of the Joint Board:

Thank you for this opportunity to comment on meeting scheduling in response to Covid-19 complications. I am writing on behalf of the Under Sixty Cod Harvesters, a fisheries trade organization representing fishing vessels under 60 feet harvesting Pacific cod with pot gear in the Gulf of Alaska, Bering Sea and Aleutian Islands. Our members also harvest sablefish halibut, salmon and herring.

USCH supports a full delay of the boards' meeting cycle, until such a time that regular in-person meetings can resume. We recommend conducting virtual meetings for *only* those urgent items that cannot be delayed. Such items should be those identified as a timely management or conservation concern. It is important that there be ample opportunity for public comment on the decisions around what is taken up virtually.

We believe a delay is the right approach for several reasons. It is not yet appropriate to gather for in-person public meetings, and virtual meetings do not offer the level of robust engagement around which the Board process is designed. Public input and stakeholder engagement are critical towards the functionality and operations of the boards and resource management. We believe it would be better to delay by a year than to change to a fully virtual format (with the exception of urgent issues).

We also believe a delay is preferable to trying to incorporate missed meetings into a future cycle. This would place extraordinary strain on Department staff and Advisory Committee participants, along with the many other Alaskan stakeholders who participate in multiple aspects of this process.

We urge the Joint Board to decide on a delay at this meeting, providing some much needed clarity to fishery and game stakeholders as they plan for their ability to engage in this important process.
